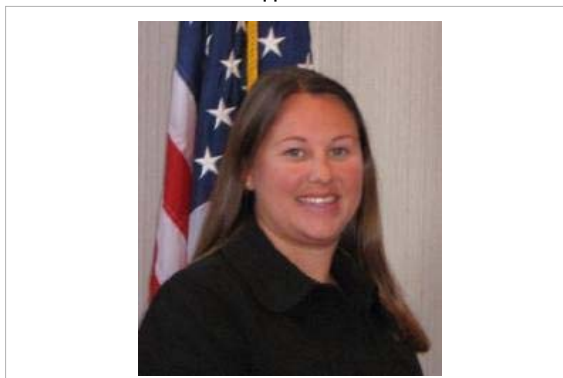
- Trial Lawyer of the Year: Assistant Public Defender William Tedford
